6. **Brazos County Precinct 4 VFD Report** (Chief Warren) Chief Warren reviewed the Brazos County Precinct 4 VFD's financials, operations, training, apparatus and facilities along with immediate and future needs.

The Chief reported their call volume for May was 78 calls and 368 calls year to date.

Training is scheduled weekly for the firefighters throughout June.

Apparatus Report: Tender 432 needs injectors replaced.

Chief Warren has located a shop with 2 bays for lease @ \$2,400/month to store trucks during renovations for Station 3.

We discussed the urgent need to hire an admin for the BCVFD4. Steve Godby and Joe Warren will meet to discuss a job description and details for this new position.

Colors for the exterior metal siding were finalized. A pre-bid meeting will be help by Arkitex at Station #3 on June 25th @ 1pm for contractors to ask questions regarding the scope of work.
